Description of Problem

The Legal Manufacturer, Sol-Millennium, with this FSN is initiating a voluntary removal of the product codes and batch numbers listed above from the market with immediate effect. Sol-Millennium has determined an increase in coring of the vial rubber stoppers of medication, when reconstituting diluent and accessing vials. Once the medication is reconstituted, visible pieces of rubber were found floating in the medication, in the barrel of the syringe used to aspirate the medication, and in the IV bag used to administer the medication.

The affected product was supplied by Vygon (UK) Ltd between November 2020 and February 2022.


